This department annually spends approximately Seventy Thousand Dollars (\$70,000.00). We suggest that an efficient head be appointed for this department of state, and that, immediately upon such appointment, he be directed to confer with us regarding a proposed drastic reduction in expenditures of his department. We must have this assistance in order to intelligently act upon the appropriations for the ensuing two years. It is very probable that many items can be eliminated. We must, however, take into consideration certain federal requirements and certain federal aid.
