Equal Employment Opportunity Federal & State Laws

Laws that protect employee rights in private employment, state and local governments, and educational institutions are as follows:



Title VII of the **Civil Rights Act of 1964** as amended prohibits discrimination in hiring, promotion, discharge, pay, fringe benefits, job training, classification, referral, and other aspects of employment, on the basis of race, color, religion, sex or national origin.

The **Americans with Disabilities Act of 1990**, as amended, protects qualified applicants and employees with disabilities from discrimination in hiring, promotion, discharge, pay, job training, fringe benefits, classification, referral, and other aspects of employment on the basis of disability. The law also requires that covered entities provide qualified applicants and employees with disabilities with reasonable accommodations that do not impose undue hardship.

The **Age Discrimination in Employment Act of 1967**, as amended, protects applicants and employees 40 years of age or older from discrimination on the basis of age in hiring, promotion, discharge, compensation, terms, conditions or privileges of employment.

In addition to **sex discrimination** prohibited by Title VII of the Civil Rights Act of 1964, as amended (see above), the **Equal Pay Act of 1963**, as amended, prohibits sex discrimination in payment of wages to women and men performing substantially equal work in the same establishment.

Retaliation against a person who files a charge of discrimination, participates in an investigation, or opposes unlawful employment practice is prohibited by all of these laws.
