RESOLUTION OF THE BOARD OF SUPERVISORS OF PIMA COUNTY, ARIZONA, DECLARING THE INCORPORATION OF THE TOWN OF MARANA, PURSUANT TO SECTION 9-101, ARIZONA REVISED STATUTES.

WHEREAS, on February 22, 1977, the Board of Supervisors continued action on a petition filed with the Clerk of the Board praying for incorporation of Marana, a community in Pima County, Arizona, having a population in excess of 1500 inhabitants; and

WHEREAS, on March 7, 1977, the Board of Supervisors again continued - to this date - action on the above-referenced petition pending answers to technical questions concerning the petition; and

WHEREAS, the Board is now satisfied that at least two-thirds of the qualified electors in the above-mentioned community to be incorporated did sign the petition pursuant to A.R.S. Section 9-101, as amended.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF SUPERVISORS that the area in Pima County, Arizona, known as Marana and described as follows:

Beginning at the NW corner of the NE 1/4 of Section 18 -T11S, R11E, G&SRB&M, Pima County, Arizona, and running East along the North line of the NE 1/4 of the NE corner of said NE 1/4 of Section 18; Thence South along the East Section line of Section 18 and Section 19 to the East Quarter corner of Section 19; thence East along the mid-section line of Sections 20, 21, and 22 to the East 1/4 corner of Section 22; Thence South to the SE corner of Section 22; Thence Easterly along the N Section line of Section 26 to the NE corner of Section 26; Thence South along the East Section line of Section 26 to the East Quarter corner of Section 26; Thence West along the mid-section line of Section 26 to the East Quarter Corner of Section 27; Thence North along the East Section line of Section 27 to a point where the East Section line of Section 27 intersects the Southwesterly right of way line of Interstate Highway I-10; Thence due West to the intersection with the North and South center line of Section 27; Thence South along the mid-section line of Section 27 to the North Quarter corner of Section 34; Thence East along the North Section lines of Sections 34 and 35 to a point where the North Section line of Section 35 intersects the Southwesterly right of way line of Interstate Highway I-10; Thence Southeasterly

along the Southwesterly right of way line of Interstate Highway I-10 to a point of its intersection with the South Section line of Section 36; Thence in a westerly direction along the South Section lines of Section 36, 35 and 34 to its point of intersection with the Northeasterly bank of the Santa Cruz River; Thence Northwesterly along the Northeasterly bank of the Santa Cruz River through Sections 34, 33, 32, 29, 30, and 19 to a point where the Northeasterly bank of the Santa Cruz River intersects the West line of the SW 1/4 of Section 19, Township 11 South, Range 11 East G&SRB&M, Pima County, Arizona; Thence continuing Northwesterly along the Northeasterly bank of the Santa Cruz River into Township 11 South, Range 10 East to its point of intersection with the West line of the SE 1/4 of Section 24; Thence North to the North 1/4 corner of Section 24; Thence East to the Northeast corner of Section 24; Thence Northerly along the common line between Range 10 and Range 11 to the SW corner of Section 18 of Township 11 South, Range 11 East; Thence East along the South line of Section 18 to the SE corner of the SW 1/4 of Section 18; Thence North along the N and S center line of Section 18 to the NW corner of the NE 1/4 of Section 18, which is the point of Beginning.

be, and hereby is, declared, pursuant to Arizona Revised Statutes, Section 9-101, as amended, THE TOWN OF MARANA.
